MODALITIES OF UTILIZATION OF FUNDS FOR THE PROJECTS OR PROGRAMMES

MONITORING AND REPORTING MECHANISM

The Board shall ensure that the funds disbursed for CSR are utilized for the approved purposes and in the manner specified.

The CSR Committee shall oversee the implementation of CSR projects, programs and activities within the approved timelines and year-wise allocations as per the CSR Policy.

The Committee shall ensure compliance with the provisions related to CSR as per the Companies Act, 2013 and the Rules made thereunder.

The Committee is authorized to make necessary modifications for smooth project implementation within the overall permissible time period. The



progress of CSR initiatives and activities shall be reported by the CSR Committee to the Board.
